Violent 'cheat' avoids prison

A "CHEATING" partner pressed a bread knife against his girlfriend's throat and then threatened to kill her, a court heard.

Tony Jogia (30), of Argyll Street, Ripley, "turned nasty" on August 29 last year after Marie Smith found a text message from another woman on the mobile she had lent him.

When she refused to give him the phone back, he threatened her, saying: "Give me the phone or I will kill you tonight", Derby Crown Court heard.

Jogia then pulled Miss Smith's hair and dragged her across the room before kicking her three times on her leg, said Mark Achurch. prosecuting. He then produced a bread knife, pressed it to her throat and threatened to kill her again.

Jogia admitted causing Miss Smith actual bodily harm as well as stealing cheques, dishonestly obtaining £50 in cash, possessing cannabis and failing to attend court.

Recorder Patrick Thomas QC ordered Jogia to do 100 hours of community punishment and put him on a two-year community rehabilitation order. He was fined £100 and ordered to pay £750 compensation and

Vigilantes beat suspected paedophile to death Life sentences for

'dreadful' murder

HREE vigilantes who beat a suspected paedophile to death were told taking the law into their own hands was never justified, as they were jailed for life today.

Daniel Poole (21) must serve a minimum of 14 years before he is considered for parole, his uncle, Steven Poole (37) will be behind bars for at least 12 years and their friend Richard Greyham (31) for 13 years.

Mr Justice Gage told them at Nottingham Crown Court that their murder of father-of-three, Matthew Murray (39) was "a dreadful crime, which not surprisingly has had a traumatic and devastating effect on his

Mr Murray was punched, stamped on and kicked as he tried to escape from Mickley following an initial attack on him in his own home in Priestley Avenue.

The Pooles and Steven Poole's girlfriend, Michelle Warriner (24), of Hawthorne Avenue, Mickley, attacked him within hours of Warriner giving a statement to the police about Mr Murray's alleged sexual abuse of a

young girl.

Mother-of-two Warriner, who struck Mr Murray with a crowbar as he lay seriously injured on the floor of his house, was jailed for eight months after admitting causing him actual bodily harm.

The Pooles also admitted the same charge and were jailed for three years concurrently to their life sentences. Mr Murray was so terrified by the beating, he ran to a bus stop on the A61 in nearby Stretton, to travel to safety in Chesterfield, the court heard during the murder trial.

Greyham then drove the Pooles to look for

his heart after his chest was stamped on. Daniel Poole had a "poor record" for violence and dishonesty offences, the court heard. Mitigating on his behalf, Peter Joyce QC, said: "The young man was an uneducated, minor criminal, an angry and easily led young man."

His uncle had believed the girl's allegation and knew somebody who had been sexually abused, the court heard.

Greyham, who had no previous convictions, was someone with a low IQ who acted vithout thinking, the court heard.

Mr Justice Gage told the trio, who were convicted of murder last week: "It was not a spur of the moment attack. All three of you vanted to have another go at Mr Murray.

Wife's plea spares alcoholic from time inside

AN alcoholic who behaved "outrageously" towards his wife has not been sent to prison because she wanted him to get

David Spencer (43) turned on Edwina Spencer at their home in Silver Lane, Elvaston, when he was drunk on January 21, Derby Crown Court heard yesterday.

He was on medication for his drink problem and taking anti-depressants when he insisted she returned to their bedroom. Mrs Spencer was sleeping in their two daughters' bedroom because he had become "rather erratic".

Clive Stockwell, prosecuting, said: "The defendant – no doubt in drink – began swallowing his tablets. He started to make advances towards his wife. She resisted and he became abusive, calling her fat and frigid."

Spencer took more tablets and refused to let his wife leave the room, causing her great fright and distress, the court heard. He eventually calmed down, positioning himself with pillows at the top of the stairs.

The couple, whose children are 12 and four, was now getting divorced, the court heard.

But Mrs Spencer, who wrote a "moving" letter to the court, did not feel prison was the answer. Recorder Patrick Thomas OC put Spencer, who admitted af-

rehabilitation order. He told him: "You're a thoroughly decent, highly intelligent man with a great deal to offer the world."
